THIS IS THE ONLY WARRANTY DELIVERED BY FED AND IS IN LIEU OF ALL OTHER WARRANTIES, WHETHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTIBILITY OR FITNESS FOR PARTICULAR PURPOSE. Such a warranty is further limited to expressed below.

2. In the event of any warranty claim, FED shall have no obligation other than to either repair or replace any item subject to warranty at its SOLE AND ABSOLUTE DISCREATION Place of repair or replacement shall be determined by FED. Freight and transportation costs to the point of replacement or repair shall be PREPAID BY CLAIMANT. Freight and transportation costs for return to claimant after repair or replacement of any failed items subject to warranty repair or replacement shall be paid by claimant unless otherwise negotiated. The claimant shall pay freight and transportation costs for return of any items determined not to be defective or not subject to warranty and therefore not subject to repair or replacement. Items replaced shall belong to FED. In no event shall FED's financial obligation or cost under this warranty exceed the market value of the equipment involved at the time of such repair or replacement, as determined by FED.

3. This warranty IS VOID AS AGAINST and does NOT cover effects, damage, or failures of or arising from: (a) components or parts supplied to FED by other manufacturers (such as hydraulic hoses, bearings, fittings and belts etc.), warranties for which will be limited to those given by the suppliers thereof to the extent transferable by FED; (b) ordinary wear and tear (such as teeth, tooth holders, rotors, wear liners, and other expendable components); (c) failure to operate the equipment in accordance with FED's and manufacturer's instructions for use of equipment; (d) failure to properly service the equipment in accordance with FEDs and manufacturing recommendations for same; (e) modification in a manner not specifically approved by FED or the use or installation in the item of unauthorized parts or components; or (f) negligent or improper use and handling of the equipment in operation or for purposes outside its design specifications. 5. This limited warranty covers only new units supplied by FED. It does NOT extend to any sale of used or rebuilt units, unless the sale order or contract for such units expressly provides for warranty coverage.
